- 60 faculty, 423 students, 23 sections students participating various degree and certificate programs
- These programs could not be offered virtually due to accreditation and licensure requirements
- Intensive planning and preparation by the Onsite Operations team to develop safety protocols and observe CDC COVID guidelines

Highlights:

- Spring saw throttle back or delay of instruction for ALL Program Courses, including clinical placements affecting six program and over 350 students.
- Move from nearly a complete face-to-face instructional model to approximately 30% face-to-face instruction (to follow accreditation and licensing guidelines).
- Slow return to clinical instruction in late April.
- Phase II reopening allowed for 23 sections to return to campus with nearly 60 faculty and 420 students supported in progression.
- Reopening Planning included details down to access and egress pathways, new lab equipment decontamination processes, small pods of students rotating through lab sessions, and implementation of campus vetted safety protocols.
- Enormous thank you to our facilities, purchasing, grounds, and safety divisions!

Dental Hygiene Laboratory Clinic

- Clinic appointments set for 9:00-11:45am and 1:00-3:45
- 10 operator stations for a maximum of 10 patients per session (morning/afternoon); clinic stations set up as every other operator to maintain 6' distancing
- Clinic patients must wait in vehicles prior to being called in for clinic admission

Dental Hygiene Laboratory Clinic cont.

- All clinic patients will be provided an N95 mask while in a campus building
- All clinic patients will be assessed verbally for COVID-19 per CDC Self-assessment Symptom Checker; along with temperature checks prior to admission. Any temperature or “yes” will result in being dismissed for the day’s visit.
- Patient handwashing and use of hand sanitizer will occur before being guided into operatory stations by student and faculty member.
