CREDIT COURSE ADDITIONS

ART 2774L Explorations in Clay, CCA

Purpose: Course is replacing an ART 2930C selected topics course; **Credit/Contact/Lab Hours:** 1/2/2; **Prerequisites:** Minimum grade of C in ART 2751C; or departmental approval; **Co-requisites:** None; **Catalog Course Description:** This course is available to students who want to further develop their clay skills by focusing on assignments specially tailored to their needs as ceramic artist. Each student will work with the instructor to create a personal project plan at the beginning of the semester. They will submit their work at intervals for evaluation of progress toward their goals; **Effective Date:** Fall 2023 (202410).

GRA 1920C Lettering Workshop, CCA

Purpose: This course has been offered as a TWK Selected Topics course every summer for 6 years now under multiple titles (prompting the need to add it as a permanent course with a course number). Also, adding this new course to our Graphics Elective list will help us promote enrollment for the course. NOTE: I do not see any current course number in the state numbering system that is a match for this course content (traditional lettering exploration). Students will need to be charged the standard lab fee. This course will be combined lecture/lab (with C designation) and be a 3-credit 4-contact hour course. 3 of the 4 contact hours are designated as lab due to the workshop nature of this course;

Credit/Contact/Lab: 3/4/3; **Prerequisites:** None; **Co-requisites:** None; **Catalog Course Description:** A hands-on, workshop-oriented exploration in learning and practicing various lettering techniques. Students will experiment with various traditional and untraditional materials to create custom typographic elements. This course meets the requirements of a Graphic's Elective. Students from any major are encouraged to enroll. No prior experience with lettering is expected; **Effective Date:** Fall 2023 (202320).

MUM 1620 Psychoacoustics and Critical Listening Skills, CCA

Purpose: Delete the "L" designation, as this course has moved to online mode only; **Previous Course Number:** MUM 1620L; **Effective Date:** Fall 2023 (202410).

MUM 2690C Avid Pro Tools 201/205D/210D Dolby Atmos, CCA

Purpose: High industry demand for certifications in new technology Dolby Atmos Immersive Sound; **Credit/Contact/Lab:** 3/5/4; **Prerequisites:** A minimum grade of C in MUM 1003L, or in MUM 1675C, or in MUM 2634L, or in MUM 2670C, or in MUM 2671C, or in MUM 2683C, or proof of current User, or Operator, or Expert certification in Pro Tools the latest version of Pro Tools; **Co-requisites:** None; **Catalog Course Description:** This course trains the student in the use of the Dolby Atmos Immersive Atmos format, the used of the Dolby Production Suite on Pro Tools, the use of the Dolby Renderer, mixing sound in Dolby Atmos, deliverables in Atmos and other surround sound formats, and in Immersive Audio Files conversions. Successful completion of this course will allow the student to obtain the Avid Pro Tools 210D User Certification in Pro Tools for Dolby Atmos; **Effective Date:** Spring2023

MUM 2691C Avid Sibelius 101 & 110 Music Notation, CCA

Purpose: Provides choice in electives for several of our specializations; **Credit/Contact/Lab:** 3/2/2; **Prerequisites:** A minimum grade of C in MUT 1011C, or in MUT 1111 or permission from the department; **Co-requisites:** None; **Catalog Course Description:** In this course the student learns and develops foundation-building themes and different ways of working in the software, as well as a clear understanding of the Sibelius interface, becomes comfortable with using shortcuts while learning how to create, edit, and print musical scores quickly and efficiently; **Effective Date:** Spring 2023

MUM 2720 Business of Music, CCA

Purpose: Drop the "C" designation as this course is offered online only; **Previous Course Number:** MUM 2720C; **Effective Date:** Fall 2023 (202410).

NUR 1470C Health and Illness Concepts of Reproductive Health and Pediatric Nursing, CCA

Purpose: Due to the changing of the program option, to improve student success we wanted to combine Pediatrics and Reproductive Health into one class and move the credit to another course to give more opportunity to cover the required material for the course; **Credit/Contact/Lab Hours:** 5/3/2; **Prerequisites:** BSC 2094C, NUR 1020C, NUR 1061C, NUR 1141C, NUR 2522C, NUR 2221C; **Co-requisites:** NUR 2223C; **Catalog Course Description:** This course includes the

concepts within the domain of health and illness and health care recipient. The course will focus on the concepts of reproduction, sexuality, family dynamics and pediatrics. Upon completion, students will provide safe nursing care incorporating the concepts identified in this course. A grade of satisfactory in the clinical/lab is required; **Effective Date:** Fall 2023 (202410).

NUR 2932C ATN - Health and Illness Concepts Mental Health, CCA

Purpose: ATN is transitioning to concept based curriculum. The course already exist for the traditional track therefore we needed to give the course a different name to meet the needs of the ATN students; **Credit/Contact/Lab:** 3/5/3; **Prerequisites:** Admission to Nursing A.S. Degree Program, minimum grade of C in NUR 1100C, NUR 2931C, NUR 2440C; **Co-requisites:** NUR 2210C; **Catalog Course Description:** This course includes concepts within the three domains of the health care recipient, health and illness, and professional nursing and health care. Emphasis is placed on each domain's concepts, including stress, coping, mood, cognition, addiction, development, and safety. The students will develop communication, assessment, intervention, and evaluation of mental health within the healthcare system. A grade of satisfactory in the clinical/lab is required. This course must be completed with a grade of C or better for program progression; **Effective Date:** Fall 2023 (202410).

PGY 1802L Digital photography II, CCA

Purpose: Course is replacing a PGY 2930C selected topics course; **Credit/Contact/Lab Hours:** 3/3/3; **Prerequisites:** PGY 1800C; **Co-requisites:** None; **Catalog Course Description:** This course is the continuation and advancement of digital photography and the electronic darkroom. The class will cover more advanced digital camera controls, lighting, composition, and hardware for the digital darkroom. Shooting, image editing, and desk top printing are covered. Requires a digital, manual SLR camera. Paper will be the student's responsibility; **Effective Date:** Fall 2023 (202410).

TPA 1200 Basic Stagecraft, CCA

Purpose: Transforming TPA 1200C into two courses, TPA 1200 and TPA 1200L, will allow students to explore basic stagecraft in a classroom or online environment in the TPA 1200 course and then take a dedicated lab course in which students will use specialized equipment, such as power tools. It will make it easier for those who want to learn about basic stagecraft but don't want to use scenic paint or power tools to learn that content. Students may decide later to take the one-credit TPA 1200L course. Live Entertainment Design and Technology students, Stage Technology Certificate students, and Film Production Technology students will be required to take both TPA 1200 and TPA 1200L; **Credit/Contact/Lab Hours:** 3/3/0; **Prerequisites:** None; **Co-requisites:** None; **Catalog Course Description:** This course examines the context of stagecraft and technical production within theater organizations, including production planning, scenic production and installation, scenic painting, and properties. This course includes hands-on activities and has a companion lab course, TPA 1200L, that may be taken at the same time or after completing this course; **Effective Date:** Fall 2023 (202410).

TPA 1200L Basic Stagecraft Lab, CCA

Purpose: Separating the lab portion from TPA 1200 enables greater flexibility for students when they take this course. Students can take the classroom course either first or at the same time as this course. This structure will allow us to

concentrate on safety, materials, and accuracy in the scene shop while working on practical projects. Not everyone who takes TPA 1200 will take TPA 1200L, but it is available to anyone who is interested in the practical application of the information learned in TPA 1200. Live Entertainment Design and Production students, Stage Technology certificate, students and Film Production Technology students will need to take both classes; **Credit/Contact/Lab Hours:** 1/2/2; **Prerequisites:** TPA 1200; **Co-requisites:** TPA 1200; **Catalog Course Description:** This hands-on lab course takes place in a scene shop in which students will learn to use power tools, practice shop safety, construct scenery, and complete scenic painting projects. This course is in-person and may be taken at the same time or after completing TPA 1200; **Effective Date:** Fall 2023 (202410).

WOH 2012 World History to 1500, CCA

Purpose: We believe that some students will find an interest in a survey-level history course that more formally incorporates examining South America, Africa and the Far Eastern world. This course will aligns UCF, so equally useful for transferability compared to the EUH series while also allowing more student choice regarding Gordon Rule (either EUH or WOH courses). Adding this course also puts us into alignment with most major colleges and universities beyond UCF, thus benefitting students who transfer to other institutions. Finally, we believe the WOH series is particularly relevant in an internationalized setting like Valencia and helps to prepare students to live and thrive in this time of globalization; **Credit/Contact/Lab:** 3/3/0; **Prerequisites:** Minimum grade of C in ENC 1101, ENC 1101H, or IDH 1110; **Co-requisites:** None; **Catalog Course Description:** Survey of the evolution of civilizations from ancient times to the modern era (1500 AD/CE) with emphasis on political, social, cultural, and economic development as they evolved in the various areas. Examines the ancient world and ancient civilizations, classical antiquity, the early nation-states in the various areas around the globe, world religions emergence and development, developments through the first millennium common era, the European Renaissance, intersection and connection between global regions including the early age of Exploration, and other topics that explore the interactions among various civilization regions. Gordon Rule course in which the student is required to demonstrate college-level writing skills through multiple writing assignments. Minimum grade C required if WOH 2012 is used to satisfy Gordon Rule requirements; **Effective Date:** Fall 2023 (202410).

WOH 2022 World History Since 1500, CCA

Purpose: We believe that some students will find an interest in a survey-level history course that more formally incorporates examining South America, Africa and the Far Eastern world. This course will aligns UCF, so equally useful for transferability compared to the EUH series while also allowing more student choice regarding Gordon Rule (either EUH or WOH courses). Adding this course also puts us into alignment with most major colleges and universities beyond UCF, thus benefitting students who transfer to other institutions. Finally, we believe the WOH series is particularly relevant in an internationalized setting like Valencia and helps to prepare students to live and thrive in this time of globalization; **Credit/Contact/Lab:** 3/3/0; **Prerequisites:** Minimum grade of C in ENC 1101, ENC 1101H, or IDH 1110; **Co-requisites:** None; **Catalog Course Description:** Survey of modern transformation of civilizations from 1500 to the present day with emphasis on political, social, cultural, and economic development as they evolved in the various areas. Examines the increasing interconnection of the various world regions emerging through the European Renaissance and age of exploration, the impact of the enlightenment and modern revolutions, the rise of modern nations throughout the world, industrialism, imperialism, and the impact to the Indian, African, Far Eastern and American backgrounds and developments, the world wars, the Cold War, postcolonialism, and other topics that explore the interactions among various civilization regions. Gordon Rule course in which the student is required to demonstrate college-level writing

skills through multiple writing assignments. Minimum grade C required if WOH 2022 is used to satisfy Gordon Rule requirements; **Effective Date:** Fall 2023 (202410).

CREDIT COURSE MODIFICATIONS

ANT 2410 Cultural Anthropology, CCM

Purpose: Course outcomes were revised to be consistent with equity-minded lens. Added Gen Ed and Gordon Rule writing outcomes in anticipation of consideration for Gen Ed Institutional Social; **Revised Prerequisites:** Minimum grade of C in ENC1101 or ENC1101H or IDH 1110; **Revised Course Description:** Cultural anthropology attempts to explain the similarities and differences in human behavior, social institutions, and ways of life of all people, past and present, by studying living cultures worldwide. This course will examine how cultural anthropologists carry out research in order to understand the ways people live in groups, create culture and adapt to their environments. A variety of topics are covered including the concept of culture, culture change, human diversity, communication, marriage, economics, subsistence, globalization and human migration, kinship, politics and power, social organization, gender and sexuality, anthropological research and field methods, ethical issues in anthropological research, and the application of anthropological thinking to real world scenarios. Gordon Rule course in which the student is required to demonstrate college-level writing skills through multiple writing assignments. Minimum grade of C is required in ANT 2410 to satisfy Gordon Rule and general education requirements; **Effective Date:** Fall 2023 (202410).

DEH 1800 Dental Hygiene, CCM

Purpose: This change assisted in clarification and enabled a more streamline set of outcomes. The learning outcomes are written in accordance with standards from our accrediting agency (Commission on Dental Accreditation). In the process of review, we believe that this new set of outcomes demonstrates equitable student learning and prepares the dental hygiene students for a successful career; **Revised Prerequisites:** DES 1100, DES 1100L, DES 1800, DES 1800L, DEH 1003, DEH 1003L, DES 1200, and DES 1200L; **Effective Date:** Fall 2023 (202410).

DES 1200 Dental Radiography, CCM

Purpose: This change assisted in clarification and enabled a more streamline set of outcomes. The learning outcomes are written in accordance with standards from our accrediting agency (Commission on Dental Accreditation). In the process of review, we believe that this new set of outcomes demonstrates equitable student learning and prepares the dental hygiene students for a successful career; **Revised Prerequisites:** DES 1020 and DES 1020L; **Revised Course Description:** Provides student with background on radiation, including: production, biological effects, properties of radiation, and radiation hygiene. Radiographic interpretation of anatomy, abnormalities, and pathology are covered in this course; **Effective Date:** Fall 2023 (202410).

DEP 2004 Developmental Psychology, CCM

Purpose: We condensed the learning outcomes and updated them to align them to the revised learning outcomes in PSY 2012, improve clarity, use more concise language, and ensure each outcome was measurable. We also used Bloom's

taxonomy to ensure each verb used matched the targeted cognitive level of the outcome; **Revised Course Description:** Designed to examine theory and research on human development from conception through death. Emphasizes physical, cognitive, social, emotional, and cultural variables which influence human development; **Effective Date:** Fall 2023 (202410).

EDF 3940 Clinical Field Experience in Curriculum and Instruction, CCM

Purpose: Changing state teacher preparation legislation and feedback from the FL Department of Education necessitate increased clinical supervision and support for EPI candidates in the field experience class to provide opportunities for coaching. 6 contact hours for faculty are commensurate with other clinical or practicum courses. 60 hours of documented classroom observation and teaching demonstration time for candidates promotes sufficient training in the Florida Educators Accomplished Practices; **Revised Course Hours:** 3/6/0; **Revised Course Description:** Clinical field experience, for teachers with a temporary certificate or prospective teachers, in a PK-12 classroom with a minimum 60-hours in a public, charter, or accredited private school which includes teaching demonstrations, analysis, and reflections on candidates' current teaching related to the Florida Educator Accomplished Practices (FEAPs). The course is reserved for those candidates seeking alternative professional certification in Florida; **Effective Date:** Fall 2023 (202410).

ETD 1031C Introduction to Construction/Drafting Tech, CCM

Purpose: Better reflect the course content and reduce the number of course substitutions currently being handled by our Career Program Advisor; **Revised Course Title:** Intro to the Built Environment; **Revised Course Hours:** 3/2/1; **Revised Course Description:** This New Student Experience course introduces students to the Built Environment, which includes the Construction & Civil Engineering Technology (CCET) and Computer-Aided Drafting & Design (CADD) programs. It provides an overview of the academic and technical requirements needed for educational and career success planning in the construction management, drafting & design, civil technology, and surveying fields. Learning activities are designed to ensure competence in the basic use of computers and application software; **Effective Date:** Fall 2023 (202410).

ETM 1604C Energy Management Concepts, CCM

Purpose: Equity-minded Course Outcomes Update; **Revised Course Description:** This course covers the impact of control systems and automation. Students will learn about the elements of a commercial energy audit. Students will also learn energy strategies involving lighting, HVAC, chiller plants, and boilers; **Effective Date:** Fall 2023 (202410).

ETM 2606C Programming Building Automation Systems, CCM

Purpose: Equity-minded Course Outcomes Update; **Revised Course Description:** This course will build upon programming concepts to prepare students for industry specific programming work required in the building automation industry. Concepts and theory will be applied to HVAC, hydronic, lighting, and building specific sequences of operations

in both line and block styles while becoming familiar with technical trends toward smart devices, question based programs, and industry specific machine learning trends related to program; **Effective Date:** Fall 2023 (202410).

ETM 2608C Automated Building Operations, CCM

Purpose: Equity-minded Course Outcomes Update; **Revised Course Description:** This course will provide students with the opportunity to experience software functionality in live building operations case studies from the point of view of the building owner. The theory of proper operations, maintenance, and capital planning will be covered as it relates to building automation, controls, and energy management. Students will learn to use and evaluate Building Automation Systems (BAS) reports, schedules, alarms, trends, fault diagnostics, and predictive maintenance techniques offered through user interface software within the building automation industry; **Effective Date:** Fall 2023 (202410).

ETM 2609C Capstone in Energy Management and Controls Technology, CCM

Purpose: Equity-minded Course Outcomes Update; **Revised Course Description:** This course continues the development of how building automation systems are designed and properly installed and commissioned which was begun in ETM 1603C. Topics include developing a commissioning plan, building automation systems commissioning, and control theory; **Effective Date:** Fall 2023 (202410).

ETM 2942 Internship in Energy Management and Controls Technology, CCM

Purpose: Equity-minded Course Outcomes Update; **Revised Course Description:** This course allows a student to earn up to 3 credit hours of EMCT Internship per semester, to gain real-world experience by working in the field with a local building automation systems company. A minimum of 5 hours a week per credit hour, for 16 weeks, totaling 80 work hours is required. Alternatively, an equivalent number of hours spent on real-world, commercial building automation systems related controls projects at the college may be completed. Three earned credits of internship requires a minimum of 240 clock hours of work. Multiple credit course. May be repeated for a maximum of 3 credits, but grade forgiveness cannot be applied; **Effective Date:** Fall 2023 (202410).

ETM 2943 Practicum in Energy Management and Controls Technology, CCM

Purpose: Equity-minded Course Outcomes Update; **Revised Course Description:** This is a planned, hands-on, technical skill building experience that provides students with an opportunity to develop their commercial HVACR and Electrical skills set required to understand and control commercial building automation systems. Through an agency partner, this Practicum involves the successful completion of an A/C, Refrigeration and Heating Technician certification program or an Electricity certification program and/or EMCT Restricted Electives per Program Chair approval. 3 credits repeatable for maximum of 12 credit hours; **Effective Date:** Fall 2023 (202410).
