4. **Regular Agenda:**

2324-257 ENC 1101 Freshman Composition I, CCM.....M. Robbins

Purpose: These recommendations are being put forth to comply with the standards set in SB266: Higher Education. They incorporate language to include acts of public speaking into ENC1101; **Revised Course Description:** Development of essay form, including documented essay; instruction and practice in expository writing; engagement in public speaking. Emphasis on clarity of central and support ideas, adequate development, logical organization, coherence, appropriate citing of primary and/or secondary sources, and grammatical and mechanical accuracy. Gordon Rule course in which the student is required to demonstrate college-level writing skills through multiple assignments. Minimum grade of C is required if ENC 1101 is used to satisfy Gordon Rule and general education requirements; **Effective Date:** Fall 2024 (202510).

Proposal 2324-257 was approved by consensus.

2324-258 MUM 2790L Music Production-Capstone, CCM.....R. Valery
Purpose: We are changing the course from Repeatable for Credit to Non-Repeatable because of enrollment management issues; **Effective Date:** Fall 2024 (202510).

There was a question as to whether there will be a "I" added to show Music Production I and Music Production II. They will not be adding that.

Proposal 2324-258 was approved by consensus.

2324-259 MUM 2791L Music Production II-Capstone, CCA.....R. Valery
Purpose: Adds an opportunity for graduating students to complete a project/portfolio initiated in the previous course (MUM 2790L) while providing additional learning opportunities;
Credit/Contact/Lab Hours: 1/3/3; **Prerequisites:** Minimum grade of C in MUM 2790L;
Corequisites: None; **Course Description:** Participation by students as technicians, producers and managers in the production of either a live audio event, or of a music recording project, closely paralleling the workings of a music production company. Multiple credit course. May be repeated for maximum of two credits, but grade forgiveness cannot be applied; **Effective Date:** Summer 2024 (202430).

The effective date was changed to Fall 2024.

Proposal 2324-259 was approved with the above change.
