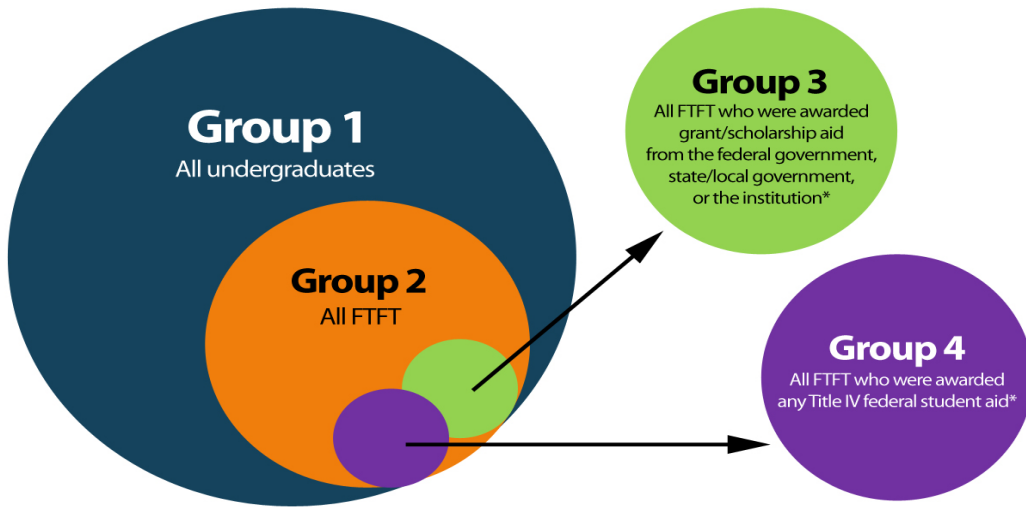

COA Revisions
