

# ARTICULATION AGREEMENT

**Between**  
**The District Board of Trustees of Valencia College, Florida**  
**and**  
**Western Kentucky University.**

**WHEREAS**, this agreement (hereinafter referred to as the “Agreement”) dated January, 25, 2017 establishes a Transfer Program (hereinafter referred to as the “Program”) in which an undergraduate student will attain an Associate’s degree in information technology, or other closely related field, from Valencia College (hereinafter referred to as “Valencia”) and then transfer to a Bachelor of Science in Computer Information Technology (CIT) program at Western Kentucky University (hereinafter referred to as “WKU”), (hereinafter collectively referred to as the “Parties”). After completing the academic requirements of the two participating institutions, the students will have earned an Associate degree from Valencia and a Bachelor of Science degree in Computer Information Technology (CIT) from WKU. This Agreement does not preclude Valencia students from attending and seeking other degrees at WKU.

## 1. Program of Study

- 1.1 Participating students shall complete the following at Valencia:
  - An Associate’s degree in Information Technology, or other closely related field as accepted by WKU. See Appendix A for course details (pages 5-6 of agreement).
- 1.2 All courses designated within the general education component of the Valencia degree will fully transfer to the general education component and/or the general elective component of WKU’s Bachelor’s degree program. Valencia students who complete an associate degree containing 30 unduplicated semester credit hours of General Education will not be required to complete additional general education courses at WKU. These credit hours are to included, per SACSCOC standards, at least one course from each of the following areas: humanities/fine arts, social/behavioral sciences, and natural science/mathematics.
- 1.3 The WKU CIT program is delivered completely online. Thus, Program participating students may complete the program without relocating to the WKU campus.
- 1.4 Students who successfully complete the aforementioned Valencia Associate’s level degree in information technology, or closely related field, will be required to complete a minimum of 36 credit hours of CIT coursework (with a grade of C or better), and satisfy all the degree requirements associated with WKU’s 120-hour Bachelor’s degree program.
- 1.5 The total Program shall satisfy all requirements for the degrees sought at Valencia and WKU.

## **2. Admission**

- 2.1 Valencia is an open-admissions institution that assesses the holders of a high school diploma (or equivalent) wishing to enter the Program and places them into courses on the basis of their academic background and demonstrated experience in specific courses.
- 2.2 In order to be admitted to WKU in the CIT Transfer Program, a student must:
- complete one of the programs of study in 1.1;
  - complete MAC – 1104 or MAC – 1105 with a C or better;
  - submit application materials to WKU for evaluation by WKU;
  - request that an official transcript from each college attended be sent to the WKU Admission Office, 1906 College Heights Blvd. #11020, Bowling Green, KY 42101-1020 (electronic transmission preferred). See <http://www.wku.edu/admissions/> or call (270) 745-2551 for questions; and,
  - meet the requirements for admission and be accepted to WKU.
- 2.3 Valencia graduates will be given the same privileges for admission to courses and programs as native WKU students.

## **3. Program Management and Reporting**

- 3.1 So as to assure the admission and academic success of participating students, WKU and Valencia agree to develop, maintain, and improve, as necessary, a Program management and reporting system.
- 3.2 Each institution will:
- Publicize the Agreement and Program among its students and faculty.
  - Coordinate Program evaluation and improvement activities as necessary.
  - List the Program in the appropriate publications and Web sites of the institution.
  - Exchange regularly updated copies of their general catalogs and any other publications, which may be helpful in advising students.
  - Agree to seek approval from the Program directors/coordinators of each institution prior to publishing materials pertaining to this agreement.
  - Provide timely information about significant changes in the Program and programs of study that relate to the preparation of participating students.
  - Provide any other information that may be helpful with monitoring and supporting the academic success of participating Program students.
  - Agree to monitor and support the provisions of this agreements to ensure consistency, program quality, and transferability for the mutual benefit of all involved parties at both institutions. This agreement will be reviewed by both institutions annually.

- Agree that each will observe regional accreditation standards, rules and guidelines and will work cooperatively to comply with reporting requirements from various agencies (e.g., SACSCOC, etc).
- Agree to monitor and support the provisions of this agreements to ensure consistency, program quality, and transferability for the mutual benefit of all involved parties at both institutions. This agreement will be reviewed by both institutions annually.
- Assess the Program annually in collaboration with participating faculty, advisors, and students to improve the Program as needed. A report of the assessment and recommendations for improvement will be provided to the CIT Academic Program Coordinator of WKU University, and the Assistant Vice President of Curriculum and Articulation at Valencia.

### 3.3 Valencia will:

- Provide WKU admission requirement information to all prospective Valencia-WKU transfer students.
- Provide the opportunity for WKU staff to make a 10 minute presentation at a Dean of Students staff meeting on each campus once a year.
- Valencia grants WKU the right to use the college's name and logo in writing for purposes of this agreement only and only upon prior approval by Valencia for each use.

### 3.4 WKU University will:



- Provide matriculation data to Valencia in an annual report that includes the number of students that matriculate at WKU and the program areas in which students matriculate to the Assistant Vice President of Curriculum and Articulation at Valencia.
- Charge Program participating Valencia students the appropriate tuition rates based on each student's registration activity. As this Program is offered as a distance learning program, students will be assessed the appropriate distance learning/On Demand tuition and fees for program classes as detailed on WKU's Tuition and Fees Schedule (<https://www.wku.edu/bursar/home-tuition-fees.php>). All other course enrollments at WKU are subject to the assessment of tuition and fees outlined on the aforementioned website.
- Evaluate and transcript credit for all courses completed at Valencia.
- WKU grants the right to use the university's name and logo in writing in keeping with WKU 's policy 08.1040 - WKU Logo Usage; Communication & Branding ([https://www.wku.edu/webservices/documents/communication\\_branding.pdf](https://www.wku.edu/webservices/documents/communication_branding.pdf)) and WKU's Communication and Branding Manual ([https://www.wku.edu/marketingandcommunications/documents/communication\\_branding\\_manual.pdf](https://www.wku.edu/marketingandcommunications/documents/communication_branding_manual.pdf)) for the purposes of this agreement only and only upon prior approval by WKU for each use.

#### 4. Term/Termination/Modification

- 4.1 This agreement will be considered in effect when signed by both parties. The agreement is effective for 5 years, unless the annual review by WKU or Valencia necessitates a new agreement be created. It may be revised by mutual agreement
- 4.2 This Agreement may be terminated by either party upon written notice to the other party given at least thirty (30) days in advance of the Termination date. However, it is understood and agreed that any student participating in the Valencia degree programs identified in section 1 specifically tracked for admission to WKU or already admitted to WKU due to this Agreement will be allowed to complete the Program, notwithstanding the termination provisions above, so long as the student remains in good academic standing and is making measured progress towards completion of a degree program. A student who satisfies these requirements will continue to receive the full benefit of any scholarship(s) awarded pursuant to § 3.4 of this Agreement, notwithstanding the termination of the Agreement, provided that the scholarship(s) was awarded prior to the date of the written notice of termination required by this section.
- 4.3 This Agreement is subject to change or modification by mutual written consent between the Parties hereto. It is understood and agreed, however, that this Agreement may be modified unilaterally by WKU as may be necessary to bring it within the purview of and in accord with the directives of the President of WKU University, and the policies of WKU University. However, it is understood and agreed that no such modifications shall negate the participation of any student participating in the Valencia degree programs identified in section 1 of this Agreement specifically tracked for admission to WKU or already admitted to WKU so long as the student remains in good academic standing and is making measured progress towards completion of a degree program.
