

### 2025-2026 Program Guide for the Technical Certificate in Emergency Medical Technology (EMT)

Please check for any program updates.

The EMT program consists of three courses of 12 college credits, that must be completed in the same term. EMT is offered on the West and Osceola Campuses each term. Check the <u>Academic Calendar</u> for registration dates and deadlines for each semester.

Fall Term August to December 16 weeks
Spring Term January to May 16 weeks
Summer Term May to August 12 weeks

Upon successful registration, you will receive an email (via MyVC) that will provide a link to register for the EMT orientation course in Canvas.

NOTICE: Be aware of the following compliance requirements that must be met by specific deadlines prior to the start of classes:

- Completion of AHA BLS-Healthcare Provider CPR certification
- Criminal background check and fingerprinting
- Record with up-to-date immunizations data

- Drug testing
- Completed Student Health Status Report
- Attendance at mandatory EMT Orientation

#### **ENROLLMENT:**

- 1) Read this program guide in its entirety to confirm you are capable of meeting the Core Performance Standards.
- 2) Must be a U.S. Citizen, a U.S. permanent resident or an International Student.
  - a) International Students: In addition to a background check required for clinical compliance (after program acceptance), a second background check from your home country is required. If you have a concern about how this may impact your program acceptance, please contact the School of Public Safety: publicsafety@valenciacollege.edu
  - b) Please review Page 3 of this Program Guide for clinical compliance information.
  - c) All individuals who have DACA, Temporary Protection Status, Refugee, Asylee status, etc. must complete the <u>Employment Authorization Document</u> (EAD) prior to submitting application.
  - d) State Social Security documentation is required to sit for Board Exam.
- 3) Must be a high school graduate with a standard high school diploma (or GED) and **must be at least 18 years of age at the start of the program**.
- 4) Submit a completed <u>Valencia Application</u> for Admission: click on 'Credit Programs'.
  - a) You will need to pay the \$35 application fee.
  - b) Satisfy the requirements for <u>Degree-Seeking Status and be in Active Student Status.</u>
  - c) Submit all official transcripts.
  - d) Admission to Valencia does <u>not</u> imply acceptance to a Public Safety program.
- 5) For your official Valencia record (either via your Valencia application or a Change of Program/Major form in MyVC), declare the Emergency Medical Technician Technical Certificate (TC) as a program of study.
- 6) After satisfying steps 1-6, register online via your MyVC account for the three EMT Program courses (EMS 1119, EMS 1119L and EMS 1431L) in the same time block (day or evening) on the same campus.
  - a) Registration for EMT classes closes at least six weeks before the start of the term.
  - b) You must register in time to attend the mandatory EMT Program Orientation for your term.
- 7) After successfully registering for the three classes, you will receive a MyVC email with orientation and compliance information.

<u>COST:</u> The **estimated** total cost (subject to change) for the EMT Program, including tuition, special course fees, and associated expenses such as background check, drug testing, immunizations, uniforms, and licensing is approximately \$2,500.

### GENERAL INFORMATION ABOUT THE EMT CERTIFICATION

The Certificate in Emergency Medical Technology (EMT) is a complete program and also can be the first part of the Associate in Science (A.S.) Degree in Emergency Medical Services Technology (EMS), which has three parts. The second part of the degree is the Technical Certificate in Paramedic Technology, and the third part consists of the General Education and Elective courses required for the degree. To earn this degree, all three parts must be completed. The EMT Technical Certificate must be completed successfully as a major requirement for continuing to the limited access Paramedic Certificate; however, the General Education and Elective courses for the A.S. Degree can be completed at any time.

**CERTIFICATION**: After you complete all three EMT courses with minimum grades of "C", your name will be sent to the Department of Health, Bureau of EMS in Tallahassee, so you will be eligible for state certification. After successful completion of the National Registry exam, you will receive your National EMT Certification. You must then follow the guidelines for obtaining your State of Florida EMT License. Students have one year from date of the program completion to pass the examination for their certification.

#### **ADDITIONAL INFORMATION:**

The EMT TC is not financial aid eligible as a stand-alone program. If you anticipate that you will use financial aid to cover the costs of the program, you must:

- ✓ Declare the AA degree or the AS Fire Science Technology (open access) as a primary program and the EMT TC as a secondary program. Financial aid will pay based on the elective credit hours you have available. For example, if you have 12 elective credit hours available, the full tuition will be covered; if you have 9 elective credit hours available, tuition cost for 9 credit hours will be covered, etc.
- ✓ The AS EMS and the AS Fire Science Academy track have the EMT certification built into the degree. The EMT classes are covered by financial aid under these declared degree programs, as the classes are required for degree completion.

## GUIDELINES FOR ALL EMERGENCY MEDICAL SERVICES LIMITED ACCESS PROGRAMS (EXCEPT THE BACHELOR'S DEGREE PROGRAMS AND ADVANCED TECHNICAL CERTIFICATES)

Valencia's EMT Program is offered through the School of Public Safety, Legal Studies, and Education, which provides information about specific program admission criteria. The Program Guides, of which this is one, are developed for a particular academic year (from August to July), and, as a rule, changes to admission and program requirements become effective at the start of an academic year. **Valencia College, however, reserves the right to change admission and program requirements as circumstances require.** If a mid-year change becomes necessary, it will be indicated for the specific program on the <u>Program Updates</u> page.

<u>Communication Policy:</u> Students are expected to check their Valencia email regularly for any communication regarding acceptance. **Paramedic Acceptance** updates are <u>only</u> communicated through Valencia College email. Students offered an accepted program seat must attend the mandatory program orientation to keep the seat and start the program. The admission decision email will include a <u>strict deadline</u> for accepting a program seat offered. If a response is <u>not</u> received by the deadline for the acceptance invite, the next student will be invited for acceptance.

<u>Mandatory Orientation:</u> The mandatory program orientation for accepted students may be held four to six weeks before the program start date. Once admitted to a program, students will receive an email via MyVC regarding the orientation date, requirements, and deadlines. The orientation materials will give the student information regarding the processes for completing background checks, fingerprinting, drug screening, and other requirements completed through the designated vendor.

### BACKGROUND CHECKS, FINGERPRINTING, DRUG TESTING, IMMUNIZATIONS, AND CPR CERTIFICATION:

The EMT Program includes student clinical rotations in external affiliate healthcare facilities, with Valencia having agreements for student clinical assignments. The affiliates' policies require that students serving in a clinical rotation be cleared of offenses that would disqualify them from participating in student clinical assignments.

Thus, all students enrolled in the EMT Program are required to submit to a criminal background check, fingerprinting, and drug testing, as well as provide documentation of specific immunizations and American Heart Association (AHA) and Basic Life Support (BLS) CPR certification following acceptance. The Orientation information sent to the student upon registration through MyVC email will provide the timeframe for meeting these requirements.

To begin the program, all clinical Compliance <u>must</u> be met by the close of business on the Friday immediately preceding the first day.

Students may need to renew their background and drug testing requirements annually. For more details, contact the School of Public Safety at <a href="mailto:publicsafety@valenciacollege.edu">publicsafety@valenciacollege.edu</a>

\*If you have a negative background check, fingerprint, or drug screening, you <u>may</u> be denied enrollment in the EMT Program due to the inability to participate in a student clinical assignment. If you have concerns regarding known background issues, it is recommended that you email questions to <u>publicsafety@valenciacollege.edu</u>

### TRANSPORTATION TO CLINICAL SITES:

If accepted to a program, students are responsible for furnishing transportation to the community and hospital facilities used by Valencia for clinical practice.

The EMT program may have clinical experiences that expose the student to blood borne pathogens via contact with bodily fluids including, but not limited to blood and saliva.

Students accepted into this program will be expected to adhere to Centers for Disease Control (CDC) guidelines for the use of Standard Precautions. The CDC defines standard precautions as "a set of precautions designed to prevent the transmission of HIV, Hepatitis B virus (HBV), [and] other blood borne pathogens when providing first aid or health care." Under standard precautions, blood and certain body fluids are considered potentially infectious for HIV, HBV, and other blood borne pathogens. Students will be expected to adhere to hand hygiene protocols and consistent use of personal protective equipment including masks, gloves and eyewear. In some of the public safety programs, students may need to conduct peer-to-peer examinations in lab settings.

### EMERGENCY MEDICAL SERVICES CORE PERFORMANCE STANDARDS FOR ADMISSION AND PROGRESSION

Emergency Medical Services is a practice discipline with cognitive, sensory, affective, and psychomotor performance requirements. Based on these requirements, the following list of "Core Performance Standards" has been developed. Each standard has an example of an activity or activities, which a student will be required to perform while enrolled in the Emergency Medical Services Technology Program. These standards are a part of the Emergency Medical Services Technology courses and of the role expectation of an Emergency Medical Services professional.

For the Emergency Medical Services Technology Program, a "qualified individual with a disability is one who, with or without reasonable accommodations or modifications, meets the essential eligibility requirements for participation in the program. The School of Allied Health at Valencia makes no preadmission inquiries concerning an applicant's disability status. Information related to an applicant's disabilities is not a part of the information reviewed by the Admission Committee.

These Performance Standards should be used to assist students in determining whether accommodations or modifications are necessary for the student to meet program requirements. A student who identifies potential difficulties with meeting the Performance Standards should communicate his/her concerns to an advisor in the Office for Students with Disabilities. The student has the responsibility to identify and document the disability and to request reasonable and appropriate adjustments. Determination is made on an individual basis as to whether any accommodations or modifications can be reasonably made.

Mobility	Physical abilities sufficient to move from room to room, maneuver in small spaces, and navigate stairwells	Moves around in patient's rooms, homes, ambulances, work spaces, and treatment areas, administer medications, lift a minimum of 100 pounds
Motor Skills	Gross and fine motor abilities sufficient to provide safe and effective emergency care	Calibrate and use equipment; position patients/clients
Hearing	Auditory ability sufficient to monitor and assess health needs	Hears monitor alarm, emergency signals, auscultatory sounds, cries for help
Visual	Visual ability sufficient for observation and assessment necessary in emergency care	Observes patient/client responses
Tactile	Tactile ability sufficient for physical assessment	Perform palpation, functions of physical examination and/or those related to therapeutic intervention, e.g., insertions of an intravenous catheter
