Insufficient reflection on what was learned while completing this FLO: little or no discussion of possible improvements. Insufficient critical evaluation of methods and results used to demonstrate each specified Essential Competency in this FLO: little or no discussion of possible improvements. Not written clearly or coherently; not presented & edited professionally.
