<b>1. Goal</b> -principal purpose of plan (include how this relates to serving students or increasing student success or supporting LifeMap)	Support the co-curricular requirement of the New Student Experience course.
<b>2. Objectives</b> -what will be accomplished and measured	NSE faculty will report that their students were able to meet the co-curricular requirement of GoBe attendance with little to no problem. Students will be satisfy their co-curricular requirement at rates comparable to the other campuses.
<b>3. Measures and Findings</b> – How specifically measures will be conducted. How will we know the objective has been achieved?	We will ask faculty to report on the percentage of students that satisfied the co-curricular requirement and compare that to other campus attendance rates to ensure we are performing at comparable levels.
<b>4. Action Plan</b> – what is the implementation plan?	We will calculate how many sessions are needed using an algorithm of the number of students enrolled in NSE at Winter Park Campus. Based on this number, we will schedule GoBe sessions at varying times and days of the week to allow students with different class schedules to attend session that will work within their schedules. We will offer all the required GoBe co- curricular sessions multiple times each term to allow student participation. Sessions will be offered in the mornings, the afternoons, and early evenings. We will also host all the GoBes on College Night when there are no classes to allow students the opportunity to meet the co-curricular requirement in one day. We will publish the

	comprehensive GoBe offerings at the beginning of each term so that students can plan attendance from the beginning of the term.
<b>5. Achievement Summary/Analysis-</b> What was learned from the assessment results? What changes will you make in your initiative for the year to come?	There was an overall lesson learned with not scheduling the SLS 1122 sections evenly between Fall term 2014 and Spring term 2015. Winter Park Campus had to cancel several GoBe sessions (co-curricular experiences) in spring term 2015 due to low enrollment. In addition, we have started to schedule the GoBe sessions on this campus right before or right after SLS 1122 sections meet so we can “catch” these students coming and going from class. Many of the GoBe sessions are offered in the same classroom so students do not have to find an additional classroom. The GoBe’s have been reduced to four selections and each GoBe is scheduled multiple times during the term. A decision to offer the Purpose GoBe’s in the middle part of the term and the Personal Connection in the later part of the term was made at the college-wide level and Winter Park Campus is scheduling according to these parameters.
